Grant of leave should be subject to availability of sufficient working strength against sanctioned strength and it should be discouraged in the last quarter of financial year and last 15 days of each quarter.

iv) The grant of leave will not hurt the revenue collection.

This supersedes all previous instructions on the subject to the extent of the powers as enumerated above.
