

**DEPARTMENTAL PROMOTION EXAMINATION FOR THE POST OF INSPECTOR
INLAND REVENUE (BS-16) THROUGH FEDERAL PUBLIC SERVICE COMMISSION.**

I am directed to refer to subject cited above and to say that in compliance of the Honourable Supreme Court of Pakistan judgment dated 05.06.2017 in Civil Petitions No.2246, 2269, 2270 & 2308 of 2016 and Recruitment Rules notified vide Notification S.R.O. No.728(I)/2014 dated 11.07.2014, the matter regarding departmental promotion examination to the post of Inspector-IR (BS-16) was taken up with the Federal Public Service Commission (FPSC), Islamabad. On completion of due formalities with FPSC and consultation with Directorate General of Training and Research, Inland Revenue, Lahore the subject examination is to be conducted in near future. As a first step, the Federal Public Service Commission has informed that they are inviting **online application from eligible candidates from 04.11.2019 to 14.11.2019 (closing date).**

2. In view of the above, all eligible employees of Inland Revenue Department in terms of Recruitment Rules notified vide Notification S.R.O. NOTIFICATION

Islamabad, the 11th July, 2014

S.R.O. 728(I)/2014.—In exercise of powers conferred by Sub-rule (2) of Rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, and Section 7(1) (b) (i) & (ii) of Federal Public Service Commission Ordinance, 1977 (XLV of 1977), the following method, qualifications and other conditions are laid down for appointment to the following posts of Inland Revenue Department under Federal Board of Revenue, Islamabad:—

METHOD OF APPOINTMENT

2. The method of appointment to the posts shall be as under:—

- (i) Initially the up-graded posts shall be filled in by existing incumbents in prescribed manner.
- (ii) Provided that if no suitable person is available for promotion, the post or posts reserved for promotion shall be filled by initial appointment and failing that by transfer.

CONDITIONS FOR PROMOTION

3. Promotion to the posts in column 2 below shall be made by selection from amongst the persons who hold the posts specified in column 3 on a regular basis and fulfill the conditions of eligibility as prescribed in column 4:—

		(ii) Stenotypist (BS-14)	05 years service in BS-14 as Stenotypist. Must pass departmental promotion examination in a manner prescribed by Federal Board of Revenue and to be conducted by the Directorate of Training & Research (IR) or FPSC or by NTS.
		(iii) UDC (BS-09)	07 years service in BS-09 as UDC. Must pass departmental promotion examination in a manner prescribed by Federal Board of revenue and to be conducted by the Directorate of Training & Research (IR) or FPSC or by NTS.

S. No.	Designation and BPS of the post	Person eligible	Conditions of eligibility
		(iv) LDC (BS-07)	10 years service in BS-07 as LDC. Must pass departmental promotion examination in a manner prescribed by Federal Board of Revenue and to be conducted by the Directorate of Training & Research (IR) or FPSC or by NTS.

Provided that the vacant post against promotional quota shall be filled by eligible incumbents of Supervisor/Stenotypist (BS-14) and subsequently UDC (BS-09) and LDC (BS-07).

QUALIFICATIONS, EXPERIENCE AND AGE LIMITS FOR INITIAL APPOINTMENT

4. A candidate must possess the educational qualifications and experience and must be within the age limits as mentioned against the posts concerned in the Schedule to this Notification provided that:—

- (i) "Experience" means, experience gained in a regular full time paid job after obtaining the required qualifications:
- (ii) The period spent by a candidate in obtaining degree of M.Phil or Ph.D in the relevant field shall be treated as practical experience up to a maximum period of two and four years respectively for the purpose of initial appointment, provided that:
 - (a) a candidate who has obtained the degree of M.Phil or Ph.D during service shall not be entitled to a double benefit of counting the said period as service towards experience prescribed for the post; and
 - (b) This concession shall not be available for the posts for which the prescribed qualifications is M.Phil/Ph.D.
- (iii) The maximum age limit shall be relaxed in respect of the candidates specified and to the extent indicated in the Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993 as amended from time to time; and
- (iv) eligibility of candidates shall be reckoned, as on the closing date fixed for submission of application in accordance with these Recruitment Rules and the Instructions issued by the Federal Government and the Federal Public Service Commission from time to time.

PROBATION

5. Persons appointed by promotion or transfer shall be on probation in accordance with the provisions of Section 6 of Civil Servant Act, 1973, read with Rule-21 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.

6. This Notification issues with the concurrence of the Establishment Division *vide* their O.M. No. 10/3/88-R-5, dated 20-03-2014 and FPSC *vide* letter No. F. 12-28/2014-RR dated -7-07-2014.
