- The terms and conditions of appointment will be as under:
 - i) They will be entitled to draw pay in the Basic Pay Scale (BPS-16) of <u>Rs.28070-2260-95870</u> plus usual allowances as admissible under the rules.
 - ii) They will be on probation for a period of one year extendable by further period not exceeding one year provided that if no order is made on the expiry of the first year of probation period, the probation will be deemed to have been extended for a further period of one year; provided further that if no order is made by the date following the term of extended period of probation, the probation will be deemed as terminated. Appointment on probation will be subject to the provisions of Section 6 of the Civil Servants Act, 1973.
 - iii) Their services will be liable to be terminated in accordance with Section 11 of the Civil Servants Act, 1973.
 - iv) Their appointment will be subject to production of <u>Medical Fitness Certificate</u> issued by the authorized Central Medical Board of the Federal Government and two character certificates from two different officers in BS-17 or above. The medical fitness certificate alongwith two character certificates and attested copies of CNIC, domicile, academic certificates, Degrees and other relevant testimonials may be submitted to FBR well before the appointment / posting is notified.

- v) The appointment will be on provisional basis subject to verification of their character and antecedents and academic certificates/ degrees and domicile certificates and subject to successful completion of prescribed training, the schedule of which will be communicated subsequently after joining the post.
- vi) In respect of all other service matters e.g. leave, medical facilities etc. they will be governed by the appropriate rules of the Federal Government as applicable to the officers of their category.
- vii) Those persons/ candidates who are already in service of any Government department/ autonomous body etc. and have applied for the post through proper channel will have to get themselves relieved from their employer before joining the post. Similarly, candidates already in Government Service who have not submitted their Departmental Permission Certificate to FPSC must submit the same to FBR immediately, otherwise they will not be allowed to join the post.

viii) The selected candidates can be posted anywhere in Pakistan.

3. If the offer of appointment on the above terms and conditions is acceptable, <u>they would</u> report to the Medical Centre for Federal Government Servants for their medical examination immediately. The original medical fitness certificate, two character certificates and willingness/ acceptance to join the post may be submitted to the undersigned by **25.01.2025** failing which the offer will be treated as cancelled. Candidates, who are not willing to accept the offer, are advised to convey their regret in writing. Notification of appointment/ posting will be issued on receipt of above documents.

No TA/DA will be admissible to them for joining the post.
