The 44th Mid-Career Management Course will commence from 28.07.2025 (Monday) simultaneously, at the above-mentioned institutes. The officers are also required to provide their latest Annual Medical Examination Reports to the respective institutes. It may be noted that as per Prime Minister's directives, issued vide the Establishment Division's D.O. letter No. 05.11.2000-T-II/T-I dated 10.06.2014, all Ministry/Division/Department are bound to relieve the officers for the training course without fail. The Ministry/Division/Department shall make stop-gap-arrangements, as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of the directions of the Prime Minister tantamount the initiation of disciplinary proceedings under the relevant rules. In addition, as per Rule 8(b) of the Civil Servants Promotion (BPS-18 to BPS-21), if an officer fails thrice for any reason to attend the mandatory training, he/she, shall will be recommended for supersession.
